RULES FOR REMITTING TENDER FEE & EMD:

TENDER FEE: Rs. 250/- to be remitted directly to the mills before collecting the tender form. For those who collect the form through e-mail the payment will be made to the mills before submitting alternatively take separate DD in favour of the mills along with the tender.

EMD: Rs. 1000/- to be remitted directly to the mills before collecting the tender. For those who submit tenders through speed post/registered post, separate DD in favour of the mills along with the tender.



Payment can be made through the QR Code attached below directly to the mill account.

The prospective bidders (venders/ suppliers) may contact our Managing Director, Shri. Umesh Krishnan, (Ph: 09446320156) / Technical Officer, Shri. ManchuRoy. N.P, (Ph: 09400622826) for clarification on details of payment and submission of tenders.

Rate for Work: Bidder rate must be firm throughout the period of the contract and there shall be no upward revision of rates quoted by the bidder for any reason what so ever. However GST or any other taxes will be as applicable at the time of billing.

Terms and Conditions are as follows:

- 1. The bidder shall carefully and thoroughly study and obtain all clarification on relevant details regarding prices and provisions necessary for successfully carrying out the supply as per the tender documents.
- 2. Bidders are required to quote only for the items mentioned in the Notice Inviting Tender (NIT).
- 3. Quote separately for each specified basic rate in unit wise.
- 4. All taxes will be applicable as per the norms.
- 5. Bidders are required to their quote for tenders invited in a single cover, containing the following.
 - a. Price bid showing rates against each item.
 - b. Proof of EMD and Tender form cost.
 - c. Specify whether excluding taxes.
- 6. The equipment should be guaranteed for performance for a minimum period of 12 months from the date of completion.
- 7. Weighing balance should be sealed by authorized Govt. agencies before the delivery.
- 8. Minimum one year warranty is required
- 9. Ensure the service of equipment by the supplier after warranty period.
- 10. The successful bidder should be ready to supply within one month after awarding the confirmed purchase order.
- 11. KCSM shall have no responsibility for any technical issue/ delays from the bidders end for non-receipt of tenders send through post/ or any other means.
- 12. The contract will be awarded to the bidder whose bid is the lowest (L1), at the negotiated rate, subject to the condition that the price is comparable with market price and bidder has the capacity and resources to carry out the contract effectively and timely.
- 13. Quotations are not properly filled, or with incorrect calculations and generally not complied with conditions, will be summarily rejected.
- 14. "Specification" shall mean all technical specification of the product/items/equipment.
- 15. KCSM does not bind itself to accept the lowest tender if any do not agree the terms and conditions of payment and completion period.
- 16. KCSM reserves itself the authority to reject any or all quotations received by assigning the reasons therefore.
- 17. The EMD of the unsuccessful bidders will be returned by the mills after completing tender formalities.
- 18. The quotation shall remain valid for acceptance for a period of 90 days from the date of submission.
